### **AMP Product Page**

If the Products specified on the Order Form include AMP Products (as defined below), then in addition to the Modernizing Medicine Standard Terms and Conditions ("**Terms and Conditions**"), the following additional provisions will apply. Capitalized terms not otherwise defined herein will have the meaning ascribed to such terms in the Terms and Conditions.

### **1.** Additional Definitions.

**1.1. "AMP E-Store**" means the AMP Product identified as "E-Store" on an Order Form, which is a website platform for Client to sell goods and services.

**1.2. "AMP Portal**" means a self-help portal provided to Client to manage the AMP Website or AMP E-Store.

**1.3. "AMP Products**" means the advertising, marketing, and promotional Products identified as AMP on an Order Form, and other products and design, maintenance or management services provided as part of such Products.

1.4. "AMP Reputation Management" means the AMP Products identified as "Reputation Management".

**1.5. "AMP Website**" means an AMP Product identified as providing a "website", but excluding the AMP E-Store.

**1.6. "Professional Provider Directories**" means electronic directories for providers and other members of the healthcare community.

1.7. "Provider Directories" means Professional Provider Directories and Public Provider Directories.

**1.8. "Public Provider Directories**" means electronic directories for patients and the general public.

# 2. AMP Product Content.

**2.1. Client Content**. Client must review and approve, and is solely responsible for, the content, information, and materials in and Client's use of the AMP Products, whether it is Client Content or Modernizing Medicine Intellectual Property. For the avoidance of doubt and except for the Client Content, all content, information, or materials that Modernizing Medicine provides or makes available as part of or in connection with the AMP Products are Modernizing Medicine Intellectual Property.

**2.2. AMP E-Store.** Without limiting Section 2.1, Client is solely responsible providing such goods and services, including all associated content for the AMP E-Store (e.g., descriptions, images, pricing, etc.), which content, for the avoidance of doubt, constitute Client Content. Modernizing Medicine is not a party to, nor responsible for, any transactions in the AMP E-Store. Client will: (i) ensure that all Client Content on the AMP E-Store is accurate and truthful, (ii) provide such goods and services in a professional manner and in accordance with industry standards, and (iii) not provide goods or services in the E-Store that are hazardous, counterfeit, stolen, or unlawful. Modernizing Medicine may immediately remove any Client Content in the AMP Products that does not comply with the Terms and Conditions, including this exhibit. **2.3. **3. Provider Directories.** Certain Client information (e.g., Client's name, contact information, specialty, Providers' names, reviews, Client Content, etc.) may automatically be included in Provider Directories. The Provider Directories may include a "contact" feature that allows users to contact Client. The Public Provider Directories may be available to public search engines. Client must meet the eligibility criteria for the applicable Provider Directory. Modernizing Medicine does not provide, and the AMP Products are not, referral services; Modernizing Medicine does not recommend or endorse any healthcare provider.

#### 4. Third-Party Access and Services.

**4.1. Third-Party Access.** For ModMed to be able to provide certain AMP Products, Client must provide ModMed with access to or with login and password information for third-party accounts or services (e.g., Facebook administrative access). # 5. Support.

**5.1. **5.2. Other Activities.** Modernizing Medicine may without notice and without liability: (i) log off accounts after extended periods of inactivity, (ii) quarantine suspected messages, (iii) modify any domain and user settings, (iv) monitor use of the AMP Products, including to verify compliance with the Transaction Documents, (v) investigate any suspected or alleged misuse of the AMP Products and cooperate with any law enforcement or other governmental entity or any other third parties in such investigation, and (vi)

disclose information about any use of the AMP Products in connection with a law enforcement or other governmental entity investigation of alleged illegal activity or in response to a court order or subpoena.

#### 6. Limitation of Liability.
